1. One of the most important actions you will ever take is choosing your staff. If the applicants are too few and not good enough, reopen the process.

While it is natural that discussion of whom to hire as staff would be in executive session, there is no reason not to announce openly how many applications were received for each position.

2. On July 4, 1776, a committee of people just like you signed a document that said: "— That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn that mankind are more disposed to suffer, while evils are sufferable than to right themselves by abolishing the forms to which they are accustomed."

That committee knew that people cling to old customs, even when they suffer from them. They also knew that power corrupts, and absolute power corrupts absolutely; and they were determined to create a government whose power was subject to the people.

- 5. The Commission website ought to have a cumulative running list of proposals for charter change. Commissioner DeRego suggested a spread sheet, but not everyone has software for that. I would hope the list includes the name of the person making the proposal, and date.
- 6. Besides agendas and minutes, the website should include for each meeting an item that includes all the public document material sent to the Commissioners relative to each agenda item. I call it "backup material", you could call it "Communications". It would look like this:

That way, both commissioners and public would have access to it, without using up large amounts of space in email. (After the meeting, documents passed out at the meeting should be added.)
