## CHARTER COMMISSION MEETING MINUTES OCTOBER 24, 1991 KIHEI SCHOOL CAFETERIA

I. CALL TO ORDER

Chair Nakasone noted a quorum present and called the meeting to order at 6:09 p.m.

- APPROVAL OF MINUTES
  Approval of October 10 and October 17, 1991 minutes were deferred to the next meeting.
- III. PUBLIC TESTIMONY
  - A. Buck Joiner (no organizational affiliation) addressed three Articles for Commission consideration:
    - 1. Article 3 3-1 County Council Composition

      Joiner noted that given the current population distribution it was no longer appropriate that the Central district have three representatives. He proposed that the Central area have two representatives, with the other seat going to either upcountry/East Maui or making it another At-Large seat.
    - 2. Article 13 13-2 Boards and Commissions
      Joiner indicated that five (5) year commitments for
      voluntary assignments were excessive and suggested that
      three (3) years was a more than sufficient term. The
      possibility of having 1/3 of the board/commission change
      each year would not only improve quality, but would
      insure continuity and be less stressful for volunteers.
    - 3. Article 8 Chapter 5 Department of Public Works
      Joiner felt that Sections 8-5.1, 8-5.2 and 8-5.3 should
      be moved to Chapter 8 Department of Planning. He stated
      that this was a more logical location for approval of
      building permits, applications and licenses. He further
      suggested that Section 8-5.4 Board of Variances and
      Appeals should be moved to the Planning Department as it
      "doesn't belong in Public Works."

Questioned by Commissioners, Joiner stated that he was not recommending changes in residency requirements, just fewer seats in the Central district. He further stated that he was not recommending district elections, as the one-man-one-vote would not be fair to Lanai or Molokai.

B. Herman Adalist (no organizational affiliation) advised Commissioners to ignore the current Charter and start over from scratch. He felt current changes to Maui have been "done at us and to us, but not with us" resulting in an unhappy community.

## III. PUBLIC TESTIMONY (Continued)

Adalist proposed a Maui County Constitutional Convention where a new Charter would be formed and would become Maui's Constitution. Maui citizens would represent themselves based on geographical and political divisions and would set up their own system of government with no council and no commissions. He noted that we need a "participatory democracy," with the people helping make an organizational system that would govern the community.

Adalist asked that Charter Commissioners recommend to voters that they agree to a Constitutional Convention, with representatives either running or drawn like a lottery. He stated that this would result in a "real state-of-the-art, year 2000 municipal government."

C. Gene Thompson (President, Kihei Community Association and Board Member of the Maui Council of Community Associations) stated that the various community associations intended to set up forums after the first of the year to explain the Charter and to solicit Charter changes from members of MCCA organizations. He stressed the need for someone to explain the Charter to these organizations.

Thompson indicated that suggestions for changes to the Charter will possibly (but not limited to) include the following:

- Article 3 3-1 County Council Composition
   Council elected At-Large vs Council elected by district,
   one-man-one-vote law would come into effect.
- 2. Article 3 3-2 County Council Terms

  Two year term vs possible proposal for 4 year staggered terms.
- 3. Article 11 11-3 Initiative Petitions
  Possible proposals to change the 20% signature requirement of voters registered in the last election.
- 4. Article 11 11-4 and 11-5 Initiative Filing and Certification and Supplementary Petitions

  Possible proposal for an allowance for supplementary petition in case of insufficiency.
- 5. Article 13 13-2 Boards and Commissions
  May possibly request an elected Planning Commission.
- 6. Additional Article Balance of Power/Powers of Appointment If proposed as Charter revision, would be of interest to community associations.
- IV. <u>COMMUNICATIONS</u> None.
- V. OVERVIEW ARTICLES VI, VII, VIII

  Deferred to later meeting.
- VI. <u>COMMUNICATIONS 91-0 Articles IX, X</u> Deferred to later meeting.

  - A. Chair Nakasone accepted summary outline from Smokey Burgess who appeared too late for public testimony. (According to

- 1. Shifting one Central Council seat to an At-Large seat.
- 2. Land Use removed from Public Works and moved to the Department of Planning.
- 3. Board of Variances and Appeals moved to the Department of Planning.
- B. Chair Nakasone appointed the following Commissioners to head Article Committees:

Allan Sparks James Cockett Articles I through VII

Article VIII

Anne Takabuki Articles IX through XIV

Chair Nakasone reminded committee chairs about the Sunshine Law and the need to post agendas prior to their committee meetings. He further asked committee chairs to report recommended changes back to the full Commission.

- C. Jamie Woodburn asked that agendas be mailed to all Commission members.
