PROPOSING AMENDMENTS TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983)

BE IT RESOLVED by the Council of the County of Maui:

1. That it does hereby propose that Section 7-4 of the Revised Charter of the County of Maui, which provides that the salary of the Mayor shall be established by ordinance, be amended to be consistent with the 1984 Charter Amendment to Section 3-5, by providing that the salary of the Mayor shall be determined by the salary commission, to read as follows:

"Section 7-4. The Salary of the Mayor. The salary of the mayor shall be determined by the salary commission."

2. That it does hereby propose that Section 9-4 of the Revised Charter of the County of Maui be revised to provide that the council shall hold a public hearing on the proposed budget and capital program for the ensuing fiscal year no sooner than the first day of April and no later than the thirtieth day of April instead of no sooner than the twentieth day of April and no later than the thirtieth day of April of the fiscal year currently ending, to read as follows:

"Section 9-4. Budget and Capital Program: Notice and Hearing. A public hearing shall be held by the council on the proposed budget and capital program no sooner than the first day of April and no later than the thirtieth day of April of the year of submission. At this hearing all persons interested shall have an opportunity to be heard. At least two weeks before the hearing, the council shall publish in a newspaper of general circulation in the county general summaries of the budget and capital program and a notice setting out the time and place for public hearing."

3. That it does hereby propose that Section 9-5.2 of the Revised Charter of the County of Maui be amended to provide that the council shall pass the budget on or before the thirty-first day of May instead of on or before the fifteenth day of May of the fiscal year currently ending, to read as follows:

"Section 9-5. Budget: Council Action.

. . .

2. The council shall pass the budget on or before the thirty-first day of May of the fiscal year currently ending. If it fails to do so, the budget submitted by the mayor shall be deemed enacted as the budget for the ensuing fiscal year."

4. That it does hereby propose that Section 9-6.4 of the Revised Charter of the County of Maui be amended to provide that the council shall pass the capital program on or before the thirty-first day of May instead of on or before the fifteenth day of May of the fiscal year currently ending, to read as follows:

"Section 9-6. Capital Program: Scope; Council Action.

. . .

4. The council shall pass the capital program on or before the thirty-first day of May of the fiscal year currently ending. If it fails to do so, the program submitted by the mayor shall be deemed enacted as the program for the ensuing fiscal year. The enacted program shall be in effect on and after the first day of that fiscal year."

5. That this resolution be submitted to the electors of the County of Maui at the next general election.

6. That the County Clerk is hereby requested to prepare the necessary ballot for presentation to the electors at the 1986 General Election.

7. That upon approval by a majority of the voters in favor of amending the above-cited sections of the Revised Charter of the County of Maui as indicated by the number of votes cast and upon official certification of such result, the amendments proposed herein shall take effect.
