PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983) RELATING TO THE TERMS OF APPOINTED BOARDS AND COMMISSIONS

BE IT RESOLVED by the Council of the County of Maui:

That it does hereby propose that Section 13-2 of the Revised Charter of the County of Maui be amended to provide that the terms of members of boards and commissions shall commence on April 1st and end on March 31st, and to provide for the terms of members appointed to new boards and commissions, to read as follows:

"Section 13-2. Boards and Commissions. Unless otherwise provided, the members of all boards or commissions shall serve for staggered terms of five years beginning on [January 2nd] April 1st and ending on [December 31st] March 31st five years thereafter. All members of boards and commissions recognized by this charter who hold office upon the effective date of this [charter] amendment shall continue in office for the balance of the term for which they were originally appointed [.] and ninety (90) days thereafter to the following March 31st.

[Within thirty (30) days of the effective date of this charter the mayor shall appoint five members each to the Board of Variances and Appeals, the Board of Ethics, the Liquor Adjudication Board, and the Liquor Commission. Of the five members appointed to each such board or commission two shall serve for a term of five years, one shall serve for a term of four years, one shall serve for a term of three years and one shall serve for a term of two years. Within thirty (30) days of the effective date of this charter the mayor shall appoint three members each to the Board of Water Supply, the

Planning Commission and the Police Commission. Of the three members appointed to each such board or commission two shall serve for a term of five years and one shall serve for a term of two years.

Each new board or commission established by this charter shall have nine members. Of the nine members initially appointed, three shall serve for a term of four years, two shall serve for a term of four years, two shall serve for a term of three years and two shall serve for a term of two years."

- 2. That this resolution be submitted to the voters of the County of Maui at the next general election.
- 3. That the County Clerk is hereby requested to prepare the necessary ballot for presentation to the voters at the 1988 General Election.
- 4. That upon approval by a majority of the voters in favor of amending the above-cited section of the Revised Charter of the County of Maui as indicated by the number of votes cast and upon official certification of such result, the amendment proposed herein shall take effect.

BE IT FURTHER RESOLVED that a certified copy of this resolution be transmitted to the Mayor.
