The purpose of the proposed resolution is to establish a department of housing consisting of a director of housing and the necessary staff.

The purpose of the proposed resolution is to change the term of office for councilmembers from two (2) years to four (4) year-staggered terms.

The purpose of the proposed resolution is to provide for the Department of Police to investigate violations of the liquor control laws of the State and the rules established by the Liquor Control Commission.

m. "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983), RELATING TO CHARTER AMENDMENTS".

The purpose of the proposed resolution is to require a majority of voters drawing ballots to approve an amendment to the Charter.

n. "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983), RELATING TO THE BOARD OF LAND USE AND CODE ENFORCEMENT OF THE DEPARTMENT OF PUBLIC WORKS".

The purpose of the proposed resolution is to establish a quasi-judicial board to hear and consider violations of the fire, housing, electrical, plumbing and building codes, subdivision ordinances, and other land use ordinances, rules and regulations.

O. "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983) RELATING TO LAPSING OF CAPITAL IMPROVEMENT APPROPRIATIONS".

The purpose of the proposed resolution is to provide for appropriations of less than \$100,000 to lapse eighteen (18) months after the date of the appropriation. For those capital improvements over \$100,000 the lapsing date would be thirty (30) months following the date of the appropriation.

P. "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983), RELATING TO A SOUTH MAUI MEMBER FOR THE MAUI COUNTY COUNCIL".

The purpose of the proposed resolution is to reduce the number of members of the Council with no district residency from two (2) to one (1), and to add one (1) member of the Council who shall be a resident of the district of South Maui.

Your Committee notes that public hearings were held on the proposed resolutions on April 16, 17, 18 and 19, 1990, pursuant to County Communication No. 90-136.

Your Committee is in receipt of the following:

- 1. A letter from Joseph Souza, Director, Department of Liquor Control, dated April 16, 1990, commenting on the Charter amendment, relating to the Liquor Commission's rules and regulations;
- 2. A memorandum to the Council Chair, from five members of the Council, dated April 20, 1990, recommending that proposed Charter amendments and public testimony be referred to the Charter Commission; and

3. A letter from William F. Crockett, dated April 26, 1990, commenting on the proposed Charter amendment relating to the election of the members of the Maui and Molokai Planning Commissions.

At its meeting, your Committee met with a Deputy Corporation Counsel. Your Committee accepted testimony from six persons speaking in support of the Charter amendment establishing a South Maui Council seat, and one person speaking in support of the Charter amendment proposing the election of members of the Maui and Molokai Planning Commissions.

Your Committee received a copy of a memorandum to Councilmember Wayne K. Nishiki, from Deputy Corporation Counsel Howard M. Fukushima, dated May 17, 1990, advising that the apportionment plan proposed in connection with the Charter amendment relating to the election of members of the Maui and Molokai Planning Commission presents a constitutionally impermissible scheme.

Your Committee noted that Section 14-3 of the Charter of the County of Maui provides for the appointment of a Charter Commission by the Mayor, with the approval of the Council, prior to March 30, 1991, but not earlier than January 1, 1991, composed of eleven members to study and review the operation of the government of the County under the Charter.

After considerable discussion, your Committee voted to refer all proposed Charter amendments to the Charter Commission for study and review, with the exception of the proposed Charter amendment authorizing the chief of police to investigate violations of liquor control laws and liquor commission rules and regulations which was deleted from the package.

Your Committee made nonsubstantive revisions to six (6) proposed resolutions.

Your Committee is in receipt of six (6) revised resolutions.

PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983), RELATING TO THE REVIEW OF SALARIES OF ELECTED OFFICIALS BY THE COST OF GOVERNMENT COMMISSION

WHEREAS, by Charter Amendment adopted in 1984, the Salary Commission has been vested with the responsibility to review and set the salaries of elected officials; and

WHEREAS, review of elected officials' salaries by the Cost of Government Commission is no longer necessary; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it does hereby propose that Section 8-14.2 of the Revised Charter of the County of Maui, be amended to repeal the provision requiring that the Cost of Government Commission review the salaries of the mayor and council members, as follows:

"Section 8-14.2. Cost of Government Commission. For the purpose of carrying out the policy set forth herein the mayor with the approval of the council shall biennially appoint a cost of government commission consisting of nine members.

Each such commission shall:

- Prepare and submit to the mayor a request for an appropriation for the operation of the commission.
- 2. Study and investigate the organizations and methods of operations of all departments, commissions, boards, offices and other instrumentality of all branches of the county government and determine what changes, if any, may be desirable to accomplish the policy set forth herein.

- 3. Be authorized to secure directly from any department, commission, board, office, or any other instrumentalities of all branches of the county government or from any individual officer or employee of the county, information, suggestions, estimates, and statistics necessary to carry out its duties.
- 4. [Review the salaries of the mayor and the council members and submit its recommendations thereon to the mayor and the council.
- 5.] Submit a report of its findings and recommendations to the mayor and council not later than eleven months after its appointment."
- 2. That this resolution be submitted to the voters of the County of Maui at the next general election.
- 3. That the County Clerk is hereby requested to prepare the necessary ballot for presentation to the voters at the 1988 General Election.
- 4. That upon approval by a majority of the voters in favor of repealing the above-cited section of the Revised Charter of the County of Maui as indicated by the number of votes cast and upon official certification of such result, the amendment proposed herein shall take effect.

PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1983) RELATING TO APPEALS CONCERNING THE USE OF NEW OR ALTERNATE MATERIALS, TYPES OF CONSTRUCTION, EQUIPMENT, DEVICES OR APPLIANCES

BE IT RESOLVED by the Council of the County of Maui:

1. That it does hereby propose that Article 8 of the Revised Charter of the County of Maui be amended by amending Section 8-5.4 to read as follows:

"Section "Section 8-5.4. Board of Variances and Appeals. The board of variances and appeals shall consist of nine members appointed by the mayor with the approval of the council.

In accordance with such principles, conditions and procedures prescribed by the council, the board of variances and appeals shall:

- determine applications Hear and variances from the strict application of any general plan, zoning, subdivision or building ordinances. The board shall hold a public hearing prior to ruling on a variance application and shall issue findings of fact and conclusions of law on decisions granting or denying variance applications.
- 2. Hear and determine appeals alleging error from any person aggrieved by a decision or order of any department charged with the enforcement of zoning, subdivision and building ordinances[.]; provided, that the council may by ordinance confer to another county agency the authority to hear and determine appeals from the decisions of the building official in the

administration of the county of Maui building code, plumbing code, electrical code, and housing code, and from any order made by the county fire chief in the administration of applicable state law and the county of Maui fire code, and the director of water supply in the administration of the rules and regulations of the department of water supply, relating to matters involving any denial of the use of new or alternate materials, types of construction, equipment, devices or appliances.

- 3. Hear and determine all other matters which the board may be required to pass on pursuant to ordinances.
- 4. Adopt rules of procedure for the conduct of the board's business."
- 2. That this resolution be submitted to the voters of the County of Maui at the next general election.
- 3. That the County Clerk is hereby requested to prepare the necessary ballot for presentation to the voters at the 1988 General Election.
