PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAU! (1983), RELATING TO A SOUTH MAU! MEMBER FOR THE MAU! COUNTY COUNCIL

BE IT RESOLVED by the Council of the County of Maui:

1. That it does hereby propose that Article 3 of the Revised Charter of the County of Maul 1983 (1989 Edition) be amended by amending Section 3-1 to read as follows:

"Section 3-1. Composition. There shall be a council composed of nine members who shall be elected at-large. Of the nine members elected to the council, one shall be a resident of the island of Lanai, one a resident of the Island of Molokai, one a resident of the district of East Maul, one a resident of the district of West Maul, one a resident of the district of South Maul, three as residents of Central Maul, and in the case of the [two] one remaining [members,] member, no district residency shall be The county clerk shall prepare required. nomination papers in such a manner that candidates desiring to file for the office of council member shall specify whether they are seeking a seat with a district residence requirement or a seat with no district residence requirement. The ballots for the primary and general elections shall, nevertheless, be prepared to give every voter in the county the right to vote for each and every council seat.

- The district of East Maul shall consist of the 2nd, 3rd, 4th, 5th, 6th, 7th, 8th and 9th Precincts in the Seventh Representative District and 11th and 12th Precincts of the Eighth Representative District.*
- 2. The district of West Maui shall consist of 4th and 5th Precincts of the Eighth the Representative District and the 7th, 8th and 9th Precincts of the Ninth Representative District.*

- The district of South Maui shall consist of Precinct of the 1st Seventh Representative District and the 1st, 2nd and 3rd Precincts of the Eighth Representative District.*
- Central Maul shall consist of the remaining area between the districts of South Maui, East Maui, and West Maui.*

*The precincts described are those precincts and the boundaries thereof for the 1982 General Election of the State of Hawaii 23 described the Notice of Intent and the election Proclamation of the Honorable Jean King, Lieutenant Governor of the State of Hawaii, dated June 17, 1982, and July 6. 1982, respectively."

- That this resolution be submitted to the voters of the County of Maui at the next general election.
- That charter material to be repealed is bracketed. New charter material is underscored.
- That the County Clerk is hereby requested to prepare 4. the necessary ballot for presentation to the voters at the 1990 General Election.
