Chair and Members:

Your Committee of the Whole, having met on January 5, 1994, makes reference to County Communication No. 93-489, from the Council Chair, transmitting a proposed resolution entitled "PROPOSING AN AMENDMENT TO THE REVISED CHARTER OF THE COUNTY OF MAUI (1993) RELATING TO THE TERM FOR THE COST OF GOVERNMENT COMMISSION MEMBERS".

The purpose of the proposed resolution is to provide staggered terms for the members of the Cost of Government Commission (COG).

At its meeting, your Committee met with the Corporation Counsel and Mr. Mark Purcell, representing the COG.

Mr. Purcell noted that the current one-year term for the COG members seriously restricts the scope of the Commission's work and fails to provide continuity of its recommendations. The COG would be valuable to the County if it conducted more comprehensive reviews and monitored and implemented the Commission's recommendations. Accordingly, the COG fully supports the proposed resolution which would improve the effectiveness of the COG by allowing longer, staggered terms for its members.

Your Committee recommended that the Council adopt the proposed resolution.
